

### **TERMS AND CONDITIONS WEBSHOP**

Hello! We are Stem op een Vrouw ("Stem op een Vrouw", "we," "us," or "our"), and we're happy to welcome you as a customer in our webshop. Please be sure to read our Terms of Service carefully before getting started. Since we are a foundation, all income from our webshop goes directly to our foundation, and is used to cover costs for f.e. our campaigns and events.

If you are signing up for an account as a consumer (hereinafter referred to as a "Shopper"), you'll need to read and agree to everything in this document. If you do not agree to the terms that apply to you, you may not use this Service. The terms and conditions described herein (the "Terms"), together with the terms and conditions of ouu Privacy Policy (together with the Terms we'll call this "Agreement"), is entered into between Stem op een Vrouw and the Shopper. Shoppers are also referred to as "you," "your", "user", or "Account Owner". By using the services or content on the Website, or any of our mobile applications (all of which we'll collectively call the "Service"), you are confirming that you have read the Agreement, and that you understand them and will comply with them.

#### **General terms**

You acknowledge and agree that your use of the Service, including information transmitted to or stored by Stem op een Vrouw, is governed by our Privacy Policy. Right now, we only accept customers in The Netherlands. ### Service, Prices and Refunds

In connection with each order, Stem op een Vrouw will charge delivery costs depending on the transaction value. The transaction fee may be amended from time to time. Stem op een Vrouw is legally obliged to offer refunds, when the customer changes their mind about buying the product, within a period of 14 days. In that case, the customer is responsible for sending the product back in the state that it was received, and we will transfer the money spent on the sale back.

Stem op een Vrouw reserves the right at any time, and from time to time, to modify or discontinue the Service (or any part thereof) with or without notice. Stem op een Vrouw shall not be liable to you for any modification, price change, suspension, or discontinuance of the Service.

# Time period of delivery

We strive to send all orders within 7 workdays. That means it can take up to 10 days for your order to arrive. We are not responsible for any delay outside of our control, due to post handling. In case items are out of stock of a longer period, we reserve the right to contact you.
